DCS offers around-the-clock temperature monitoring via Trane Ensemble, which provides 24/7 alerts and weekly trend reports directly to the quality department. In the event of any temperature variation, the system notifies both engineering and facilities teams every 15 minutes, ensuring immediate response and correction if needed.

Shipment integrity is also a top priority. DCS uses data loggers for cold-controlled shipments and ensures refer truck validation before departure. Quality assurance confirms that every truck meets temperature specs before leaving the facility, and backup delivery protocols are in place to mitigate potential issues. EDI integration and Power BI reporting add an additional layer of visibility and connectivity into Acella's supply chain systems.

DCS's facility are FDA registered, DEA licensed, NABP accredited, and currently undergoing UL certification. The latest addition to the cold storage infrastructure features reinforced wall construction, providing added security—even in the face of natural disasters.
